# 2025 Trustee Election Fact Sheet

# General

All the shares in Counties Energy Limited are held by the trustees of the Counties Energy Trust (formerly, Counties Power Consumer Trust) for the benefit of the Consumers of Counties Energy Limited.

In the past year, discounts of approximately \$13.3m (incl GST) were credited to Consumers power accounts.

# 2025 Election

Five trustees are elected to the Trust by Consumers of Counties Energy Limited. The current trustees are: Christine Rupp (Chair), Michael Marr, Don Thomson, Megan Matthews, and Alan Eyes.

The trustees are elected on a 'rotational basis' as prescribed by the Trust Deed and for the 2025 election, two trustee positions require election.

An election to fill the vacancies will occur by postal and online voting concluding on Saturday 9 August 2025.

## Nominations

Nominations for the vacancies will open on Tuesday 6 May 2025 and close at 12 noon Tuesday 17 June 2025.

Candidates must be aged over 18 years, be resident in the district and a Consumer of Counties Energy Limited.

Nomination forms will be available from the Returning Officer, by phoning 0800 922 822 to have one posted out, or calling at the offices of Election Services, 167 Victoria Street West, Auckland Central (entrance off Dock Street) or downloading one from <u>www.countiesenergytrust.org.nz</u>

A candidate information handbook is also available to all candidates.

# **Consumer Roll**

Those eligible to vote at this election will be Consumers of Counties Energy Ltd as at the close of the roll at **5pm Friday 27 June 2025**.

Each Consumer will be distributed one voting paper, regardless of the number of electricity connections that the Consumer may have. In respect of joint Consumers, a vote will be deemed to have been exercised in the name of the joint Consumers upon receipt of the completed voting paper by the returning officer.

# Voting period

Voting information will be sent to all eligible Consumers from **Friday 18 July 2025**.

Consumers who receive their power accounts by email should expect to receive their voting information by email, and those consumers who receive their power accounts by post should expect to receive their voting information by post.

Consumers who receive their voting information by email will receive a link and personalised online voting credentials and will be able to cast their vote online only.


Consumers who receive their voting information by post may vote by;

- posting their completed voting paper back to the returning officer using the replypaid envelope; or
- voting online (using the unique voter credentials shown on the voting paper); or
- hand delivering their completed voting paper to a ballot box at the Counties Energy Trust, Unit 6, Level 2, 23 Hall Street, Pukekohe.

To be counted, all completed votes must received by the returning officer by **12 noon, Saturday 9 August 2025**.

The preliminary result will be known as soon as practicable after 12 noon, Saturday 9 August 2025.

# About the Trust & the Role of Trustees

# **Counties Energy Trust**

Trustees hold all the shares in Counties Energy Limited on behalf of consumers (the beneficiaries) who are connected to the electricity network. Their task is to ensure the value of the investment is protected and enhanced, now and into the future.

### What is the role of a Trustee?

- To appoint the Directors.
- To act as diligent shareholders in monitoring the performance of the Company.
- To comment on the annual Statement of Corporate Intent.
- To approve any major transactions and any new business of the Company.
- To report to Beneficiaries annually.
- To undertake an ownership review at least every 10 years.
- The Trustees are not to act as Directors of the Company nor take any part in management.

### How much time is required?

- Trustees meet monthly (generally 2 3 hours plus preparation time) with some additional meetings as required.
- An annual meeting of two hours.
- Meetings with Directors which are generally two halfdays per annum.
- Two Industry conference/meetings per annum (out of the area) involving two days each.
- Ad hoc meetings and events.
- Ongoing review of emails, news articles, industry material, etc.
- Contribution to submissions and Trust comms.

# What is required of a Trustee?

- To be familiar with and to act in accordance of the Trust Deed, and the Trusts Act 2019.
- Strong communication skills with an ability to effectively listen, assimilate various data, contribute ideas with a positive, solution-based attitude, and to act in a cohesive way once decisions are reached.
- To think strategically (to see the bigger picture).
- To understand and interpret financial, performance and regulatory reports.
- To study and discuss current and proposed policy impacting consumers, including contribution to submissions to the Government and Regulatory bodies such as the Electricity Authority and Commerce Commission.
- Maintain a knowledge of the electricity industry and how this may impact consumers, the Company and the Trust.
- Commitment to act honestly and without bias, as well as respecting confidentiality.
- The time and energy to commit to the role.

#### What is the remuneration?

- Trustee fees are reviewed annually.
- Currently the Trustee annual honorarium is \$19,240 with a meeting allowance of \$340 per meeting.

Note – this information is compiled to assist prospective candidates. It is a brief overview of complex requirements under the Trust Deed and various statutory and regulatory enactments.
